5. Sealed bids must be submitted to the Golanjor Rural Municipality, Office of the Rural Municipal Executive by hand before 12.00 noon on 2075/11/07. Bids received after this deadline will be rejected.

The bids will be opened in the presence of bidder's representatives who choose to attend after 14.00 PM on 2075/11/07, at the office of Golanjor Rural Municipality, Office of the Rural Municipal Executive, Gwaltar, Sindhuli. Bids must be valid for a period as indicated in table above from counting from the days of bid opening and must be accompanied by a bid security, the amount and validity period as given in the table.
7. Bidders are advised to visit the site and access the actual site conditions before submitting their bid.
8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original date of the bid submission.
9. The Golanjor Rural Municipality, Office of the Rural Municipal Executive, Gwaltar, Sindhuli reserves the right to accept or reject, wholly or partly and or all the bids without assigning the reason, whatsoever.
